

Cambodian Children's Fund Fraud Alert



Cambodian Children's Fund (CCF) has received a number of reports of a phishing e-mail that has the appearance of being sent from Scott Neeson and CCF. This e-mail is often in the form of a personal letter (with information copied from the actual CCF web site) asking that individuals accept and cash money orders, then purchase another money order and send it to Cambodia.

In a related illegal e-mail scam, individuals are asked to sell tractors and agricultural equipment to someone claiming to be Scott Neeson.

THESE AND SIMILAR SOLICITATIONS ARE NOT GENERATED BY, OR IN ANY WAY AFFILIATED WITH THE WORK OF CAMBODIAN CHILDREN'S FUND, AND ARE FRAUDULENT ATTEMPTS TO OBTAIN PERSONAL AND FINANCIAL INFORMATION FROM INDIVIDUALS.

Sadly, non-profit organizations are frequently prey to e-mail scammers - but neither CCF, Scott Neeson, nor any legitimate organization would ask for personal or financial information in an e-mail.

What to do if you receive an email like the example below:

DO NOT respond to the email or enter any personal information.

DO NOT access any links provided within the body of the e-mail and do not, under any circumstances, provide any personal information through this media.

You can also FORWARD THE SCAM EMAIL TO spam@uce.gov. The U.S. Federal Trade Commission (FTC) will place your email in a database and use the combined information to track down and prosecute the scammer/spammers.

An example of a hoax email:

GOOD DAY TO YOU SIR / MADAM

I AM SCOTT NEESON A HOLLYWOOD FILM EXECUTIVE AND THE FOUNDER OF THE CAMBODIA CHILDREN'S FUND (CCF). THIS IS AN ORGANIZATION FOUNDED TO DEVELOP AND PROVIDE FOR THE CAMBODIA CHILD IN CRITICAL CONDITION. WITHIN FOUR SHORT YEARS, THE CCF HAS GROWN TO INCORPORATE THREE SEPARATE FACILITIES, WHERE NEARLY 300 CHILDREN RECEIVE NUTRITION AND HOUSING, AS HOUSING, AS WELL AS MEDICAL TREATMENT, DENTAL SERVICES AND VACCINATIONS.

WE ARE IN NEED OF HONEST PEOPLE WHO CAN HANDLE PAYMENT SUCH AS DONATIONS THAT WE RECEIVE FROM THE GOOD CITIZENS OF AMERICA AND CANADA .BY THIS I MEAN MOST PEOPLE IN THIS AREAS MAKE DONATIONS TO US WITH CHECKS. WHICH CAN,T BE PROCESSED INTO PHYSICAL CASH HERE IN CAMBODIA.

WE WILL LIKE TO GIVE THIS OPPORTUNITY TO AN HONEST AND GOD FEARING APPLICANT WHO CAN HELP US PROCESS THIS PAYMENTS AND SEND THEM DOWN TO US IN OUR HEAD OFFICE IN THE UK, SO THAT OUR WORK HERE CAN BE ALOT MORE EASIER. WE WILL ALSO BE AWARDING WEEKLY PAYMENT AS SALARY FOR THE ASSISTANCE RENDERED. WHICH WILL BE \$200 A WEEK. IF INTERESTED, PLEASE PROVIDE THE BELOW INFORMATION SO THAT WE CAN ADD YOU AS OUR FUNDS PROCESSING AGENT IN YOUR AREA SO THAT WE CAN SEND YOUR DETAILS TO THE GOOD CITIZENS WHO WANT TO HELP DONATE FUNDS IN FORM OF CHECKS, SO THAT THEY CAN ISSUE IT TO YOU DIRECTLY. THIS ARE THE DETAILS NEEDED
