THE SUPPORT POLICY REINFORCEMENT WAS UNDERTAKEN BY PROVIDING STUDENTS WITH ALTERNATIVE SCHOLARSHIP OPTIONS AND EDUCATIONAL PATHWAYS, SUCH AS VOCATIONAL TRAINING. CCF HAS BEEN TRYING TO EXPAND OUR SCOPE BEYOND THE INITIALLY PLANNED SOCIAL ASSISTANCE SCHEMES (NAMELY EQUITY CARDS) - THAT IS WE'VE BEEN ABLE TO FACILITATE OUR BENEFICIARIES TO OBTAIN NSSF FOR INFORMAL WORKERS. AS A RESULT, OUR 1,318 COMMUNITY BENEFICIARIES (758 FEMALES) WERE ISSUED THE NSSF CARDS. FURTHERMORE, WE FACILITATED 1,226 FAMILIES TO RECEIVE CASH SUPPORT UNDER THE AT-RISK HOUSEHOLD FAMILIES SCHEME (FOR A MAXIMUM OF 3 TIMES ONLY). LAST BUT NOT LEAST, AMONG THE 1,333 FAMILIES WHO WERE FACILITATED BY CCF TO GET AN INTERVIEW FOR AN AT-RISK HOUSEHOLD CARD, 1,209 FAMILIES WERE ISSUED THE CARD.
