LEAVING A GIFT IN YOUR WILL TO CAMBODIAN CHILDREN'S FUND



After you have considered your family and loved ones, we would be honoured to receive a gift in your will.

Frequently Asked Questions

What type of gift can I leave to Cambodian Children's Fund?

You can leave a gift in your will as either a percentage of your estate, or as a sum of money you wish to donate.

Will my gift make a difference?

Every gift makes all the difference to the children and families we support. Leaving a gift which will make the impact you want for the world is something everyone can do. Every gift matters.

How will my gift be used?

At the time of receiving your gift, it will be used towards critical needs and/or capital projects across Cambodian Children's Fund's core programs of Education, Leadership, Career and Life Skills, Childcare, Community Outreach and Healthcare.

If I want to add a gift, should I make a new will?

To ensure your wishes are accurately reflected, it is important to review your will as your circumstances change. If you are happy with your wider will and just wish to add a gift to Cambodian Children's Fund, your legal advisor can let you know how to do this easily.

Are there any tax benefits to leaving a gift in my will?

In some countries, a gift in your will to a charity can save taxes which would be payable. Be sure to ask your legal advisor about this.

Whole estate

When you leave everything you own.

"I give the whole of my estate, free of all duties to Cambodian Children's Fund Australia Limited, ABN 58 639 162 575, Suite 89, 78 William Street, Sydney, in the state of New South Wales for the general purpose of the said organisation and I DECLARE that the receipt of the Cambodian Children's Fund Australia Limited authorised officer shall be sufficient discharge to my trustees who shall not be obliged to see the application thereof."

A share of your estate

When you leave a portion or percentage of what's left of your estate after you've taken care of your loved ones and expenses. It's not a specific amount of money, so it gives you peace of mind no matter the final size of your estate.

Residuary bequest

When you leave the whole or a portion or percentage of what's left of your estate after you've taken care of your loved ones and expenses. It's not a specific amount of money, so it gives you peace of mind no matter the final size of your estate.

"I give the rest and residue of my estate to Cambodian Children's Fund Australia Limited, ABN 58 639 162 575, Suite 89, 78 William Street, Sydney in the State of New South Wales for the general purpose of the said organisation and I DECLARE that the receipt of the Cambodian Children's Fund Australia Limited authorised officer shall be sufficient discharge to my trustees who shall not be obliged to see the application thereof."

A specific amount of money

When you leave a specific amount of money.

"I give the sum of _____dollars of my estate, free of all duties to Cambodian Children's Fund Australia Limited, ABN 58 639 162 575, Suite 89, 78 William Street, Sydney, in the state of New South Wales for the general purpose of the said organisation and I DECLARE that the receipt of the Cambodian Children's Fund Australia Limited authorised officer shall be sufficient discharge to my trustees who shall not be obliged to see the application thereof."

Legal Advice

We recommend that you seek legal advice when preparing your will to ensure that your testamentary intentions are fully achieved. Your solicitor can advise on all aspects of estate planning and tax matters such as trusts, guardians, asset valuation and power of attorney.
