Cambodian Children's Fund (CCF) is registered in the US as a 501(c)3 not-for-profit organization no.20-0764162. Donations in the US are tax-deductible to the fullest extent of the law. CCF is also registered in the State of California and the Kingdom of Cambodia.

Cambodian Children's Fund (CCF) is registered in Cambodia as an International Non-Government Organization through a Memorandum of Understanding with the Royal Government of Cambodia which authorizes it to conduct its humanitarian activities and implement its approved projects within the laws and regulations of the Kingdom of Cambodia. CCF has been granted exemption from tax on profits by the General Department of Taxation in Cambodia.
