AN ADDITIONAL 80 CHILDREN AGES 2-6 BENEFIT FROM DAYCARE SERVICES AND PRE-SCHOOL/KINDERGARTEN STUDY. SEVENTEEN INFANTS AND TODDLERS RECEIVE DAY TIME CARE AT THE CCF NURSERY, WHICH IS HOUSED AT THE COMMUNITY CENTER. MORE THAN 160 STUDENTS BENEFIT FROM EVENING CLASSES AT CCF'S SATELLITE SCHOOLS.
