CCF PROVIDES ACCESS TO BOTH FORMAL AND INFORMAL EDUCATION TO CHILDREN RANGING FROM PRE-SCHOOL TO UNIVERSITY. CCF'S RESIDENTIAL AND NON-RESIDENTIAL FACILITIES PROVIDE CHILDREN ONCE DEEMED "UNREACHABLE" WITH AN INTENSIVE ACADEMIC CURRICULUM FOCUSED ON DEVELOPING ENGLISH, KHMER, MATHEMATICS, SCIENCE, AND DIGITAL LITERACY SKILLS IN ADDITION TO A FOCUS ON THE EXPLORATION OF CAMBODIAN HISTORY, ARTS AND CULTURE. CCF OPENED THE NEESON CRIPPS ACADEMY (NCA). NCA COMBINES PUBLIC SCHOOL CURRICULUM WITH ADVANCED LEARNING SPACES AND EQUIPMENT; SERVES AS A TEACHER EDUCATION CENTER AND HUB FOR THE LOCAL COMMUNITY. IN 2018: 1,956 CHILDREN ENROLLED IN KINDERGARTEN, PRIMARY, SECONDARY AND TERTIARY EDUCATION PROGRAMS. 111 NEW STUDENTS (56 FEMALE) ACCEPTED INTO KINDERGARTEN AND FULL-TIME EDUCATION.

SINCE MOST FAMILIES ARE MIGRATING FROM RURAL PROVINCES, THEY DO NOT HAVE ANY DOCUMENTATION TO CLAIM THEIR CITIZENSHIP, WHICH THEY ARE EXCLUDED FROM RECEIVING PUBLIC HEALTHCARE. CCF'S MEDICAL CLINIC PROVIDES BASIC TREATMENT, VACCINATIONS, AND MINOR SURGICAL PROCEDURES TO MORE THAN 7,700 PEOPLE ANNUALLY. THIS IS NOT INCLUDED CCF'S DENTAL AND EYE CARE. IT IS THE ONLY FREE MEDICAL CLINIC OF ITS KIND IN CAMBODIA - SERVING CAMBODIANS OF ALL AGES, REGARDLESS OF THEIR AILMENTS. 88% OF CHILDREN IN CCF'S CARE STAY WITH THEIR FAMILIES/FOSTER FAMILIES/KINSHIP CARE, OR IF IN HIGHER EDUCATION, THEY STAY IN A TRANSITIONAL HOME. HOWEVER, CCF IDENTIFIED SOME CHILDREN AS "MOST AT-RISK CHILDREN," WHO WERE ABANDONED BY THEIR FAMILIES, VIOLENCE SURVIVORS, OR AT CONSTANT RISK OF ABUSES AND HUNGER. MANY WERE REFERRED TO CCF BY THE NATIONAL POLICE / CHILD PROTECTION UNIT. FOR THESE CHILDREN, CCF HAS SPECIAL 24-HOUR CARE FACILITIES, INCLUDING A NURSERY. CHILD PROTECTION UNIT (CPU)

CRIMES AGAINST CHILDREN INCLUDING HOMICIDE, SEXUAL ASSAULT, CHILD TRAFFICKING AND ALL FORMS OF SERIOUS ABUSE REQUIRE A SPECIALIZED AND COORDINATED RESPONSE FROM INVESTIGATIVE AND SUPPORT AGENCIES. THE CPU IS A CCF AFFILIATED PROGRAM SET UP TO PROVIDE THE HIGHEST LEVEL OF SERVICE TO CHILD VICTIMS OF ABUSE OR ASSAULT REGARDLESS OF GENDER, CULTURAL BACKGROUND OR IMPAIRMENT. WORKING IN PARTNERSHIP WITH THE CAMBODIAN NATIONAL POLICE AND SUPPORTING ORGANIZATIONS, THE CPU PROVIDES INVESTIGATIVE RESOURCES AND SUPPORT, AFTERCARE, JUDICIARY SUPPORT, AND MAJOR CRIME CO-ORDINATION TO DETECT OFFENCES AND PROSECUTE THOSE THAT COMMIT THESE HORRIFIC CRIMES AGAINST CHILDREN. CPU'S PRIORITY IS THE PROTECTION AND CARE OF THE MOST VULNERABLE OF VICTIMS: CHILDREN.
